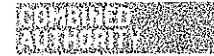

**Sheffield City Region Mayoral Combined Authority & Local Enterprise Partnership: Register of Members' Interests Form**


